We engage in *meaningful dialogue* with state and community leaders and others on the topics Alabamians care about the most.



## WHY WE MATTER

Good leaders use good information to make sound policies. This is what PARCA provides: trustworthy, non-ideological data, policy research, and evaluation so that public decisions might be made, and public money, both tax dollars and charitable donations, might be spent, informed by fact, not rhetoric.

# **Major Accomplishments**

PARCA is stubbornly nonpartisan and non-ideological. We do not endorse, advocate, or support candidates, policy positions, or political ideas. Rather than arguing for an outcome, our research defines issues, explains the context, and offers options to inform the decision-making of state and local leaders. Sometimes, a policy decision is to take *no* action. Other decisions are made at the administrative or staff level and, while important, are not apparent to most people. When a decision culminates with a vote, the journey to that vote may take years. Consequently, pointing to "wins" can be a challenge. However, taking a long view, we can point to projects and research which have had a significant impact.

- PARCA research on local support for schools led to the proposal and adoption of Amendment 778, requiring a minimum of 10 mils of local support for schools. PARCA worked with the Alabama Departments of Education and Revenue to determine necessary changes in local tax collections to comply with the Amendment.
- PARCA's study of court costs helped curtail the perpetually increasing uncollectable court costs to pay for the operation of the justice system.
- PARCA conducted proof-of-concept research for Alabama's First Class Pre-K and continues to conduct annual reviews and evaluations of the program.
- PARCA worked with the Alabama Legislature to design the Rolling Reserve Act, which has ended proration in the state's Education Trust Fund.
- PARCA assisted the City of Montgomery, Jefferson County, and the state develop SMART budgeting practices.
- PARCA research, in collaboration with the Business Education Alliance and others, led
  to the restoration of funding for mentors for first-year teachers, tightened quality
  standards for career technical education offerings, renewed investment in the
  Alabama Reading Initiative, and encouraged the development of the Alabama Math
  Initiative.
- PARCA research led to the creation of the Legislature's Joint Budget Task Force.
- PARCA research on regional collaboration has identified opportunities for improved collaboration and more efficient public spending in Jefferson County, the Shoals, and the Wiregrass, turning cooperation into a goal rather than a threat.
- PARCA's long work on the Alabama Constitution, including our own reorganized version of the Constitution with amendments organized by county and a catalog of local acts, helped lead the way to the reorganization and recompilation of the Alabama Constitution in 2022.
- PARCA is currently conducting the only major research studying the implementation of the state's 2019 Literacy Act and offering recommendations to improve the delivery of literacy instruction.

In recent years, policy sessions have explored municipal government, state budgets, mental health, corrections, workforce development, the role of the modern governor, early literacy, and childcare. The meeting draws a politically, economically, and professionally diverse mix of 350+ business and civic leaders, elected officials and candidates, state and local government employees, and nonprofit leaders.
